

The minutes of the Ladies Branch meetings from 1924 to 1950, found in a small booklet, were edited for ease of reading by adding words, mostly prepositions and conjunctions. Grammar and spelling were, punctuation was added and the capitalization of words was made consistent throughout, all while trying to preserve the writing styles of the secretaries. Initials and/or first names have been added where names are ambiguous such as “Miss Raguin” or “Mrs. Sutherland”. Where the entries were not clearly legible, a second opinion was solicited and a consensus was reached, based on other words and letters in the text and the context of the sentence in which the word(s) appear. Page breaks have been removed and spaces added between paragraphs. Explanatory notes appear in [square brackets].

1924

Dunany Country Club

October 1924

The annual meeting of the Ladies Branch of Dunany Country Club took place at the home of Mrs. R.H. Dumbrille, 596 Melrose Ave, on the evening of October 17th, twelve members being present. The minutes of the previous meeting could not be read, having been left in Dunany. The treasurer's report was confirmed and adopted. It was suggested that the secretary write letters of thanks to Mrs. E.H. Wilson, Mr. Bryant and Mr. and Mrs. Cook for prizes donated by them during the summer. During the month of August, competitions were played as follows:

1st Sealed hole competition won by Miss K. McRobie, prize donated by Mrs. E.H. Wilson.

2nd Flag competition won by Mrs. Patterson and Miss Joss, prizes donated by Mr. Bryant.

3rd Driving, putting and approaching competition won by Mrs E. H. Maw and Miss Moore, donated by Miss McRobie.

4th Six holes won by Mrs. Hamilton, donated by Mr and Mrs. Cook.

It was moved to write Mr. Maw, also thanking him for procuring the flag poles so reasonably. The election of officers next came up for discussion. It was moved by Mrs. Hughes and seconded by Mrs. Brennian that the old officers continue for the ensuing year. The discussion next arose whether it would be advisable to hold a bridge or dance to raise funds for the club. Mrs. Brennian kindly offered to obtain Mrs. Clogg's home for an evening of bridge, subsequent to the approval of the men of the club. Another meeting will be held at Miss McRobie's home on Thursday, October 25th to arrange the final details. It was decided that the office of secretary-treasurer would be combined with that of the secretary.

A meeting was held on Thursday, October the 3rd at the home of Miss McRobie. There were present 14 members. It was decided to hold a bridge on November 12th at Mrs. Clogg's home, 1 Murray Avenue, Mrs. Clogg very kindly having offered her home. 6\$ was agreed per table. 8\$ was discussed but 6\$ was carried by the showing of hands. Mrs. Brennian was appointed convener of the Entertainment Committee, later choosing Mrs. Parkes, Mrs. W.H. Sutherland, Mrs. Hughes and Mrs. Culross. It was moved by Mrs. Hughes, seconded by Mrs. Culross and carried that we buy new sharp pencils for prizes for each table. Letters were written to Mrs. and Mr. Clogg thanking them for the use of their home and Mr. McRae for the use of chairs for the evening.

On the evening of Nov 13th, a very successful bridge and dance was held at the home of Mr. and Mrs. Clogg. Everything passed off very well. There were 26 tables at 6\$ per table. All the members turned out and bridge was played until eleven. Refreshments were served consisting of sandwiches, cake, coffee and punch. Then Mr. Dumbrille sang and Mr. Hirse recited, after which dancing was in order. After the expenses were taken out, the sum realized was 135\$, which was handed over to the Men's Branch of the club. Expenses as follows: Prizes 11.25, Dishes 6.80, Doilies ribbon, 75¢, Maids 7\$. All refreshments were provided by the ladies.

1925

Season July 1925

The annual meeting of the Dunany Country Club (Ladies Branch) was held on the course on the 7th of July. The president occupied the chair. The minutes of the previous meeting were submitted and approved. The election of officers then took place on a motion by Mrs. Parkes, seconded by Mrs. Dumbrille. The officers from the previous year were reelected. The purchasing of equipment for the clubhouse was then decided on. The treasurer was authorized to purchase an oil stove, kettle, pail, china and four tables. It was proposed to hold a bridge at the clubhouse to raise funds, which was held on the 20th of July and realized the sum of 12\$.

Also, a bag was donated by the president to be raffled, which netted the sum of \$12.50. A donation was received from Mr. E.H. Wilson of Lachute of \$10, and 2 dozen tea spoons were donated by Mrs. Colin Campbell. Trophies were donated by various members and friends throughout the season. Also, eight spoons, were donated by the Men's Branch, which were played for weekly. A fully attended tea brought a very successful season to a close.

1926

Season Summer 1926

The annual meeting of Dunany Country Club was held at the clubhouse on July 5. The president occupied the chair. The minutes of the previous meeting were submitted and approved. The election of officers then took place. On a motion by Mrs. Maw, seconded by Mrs. Parkes, Mrs. Henry Hodges was elected president. It was proposed by Mrs. Hughes and seconded by Mrs. F. Hamilton, Mrs. Culross was elected vice president. It was proposed by Mrs. Martin and seconded by Mrs. McRobie. Mrs. W.H. Sutherland was elected secretary-treasurer. It was proposed by Mrs. Parkes, seconded by Mrs. T.D. McRobie that Mrs. Hamilton be elected chairman of the Handicap Committee. It was proposed by Mrs. Parkes and seconded by Mrs. Patterson, that Miss Kitty McRobie be elected honorary president. The president served tea at the close of the meeting and a sealed hole competition was held, Mrs. Maw being the lucky winner.

July 5th 1926

Amid hearty applause, Mrs. Hodges our president took the chair. A discussion on ways and means of raising funds, to be used as requirements arose, was participated in. It was moved by Mrs. Culross, seconded by Mrs. Martin and carried that a bridge be held occasionally in one of the homes in the evening. It was moved by Mrs. Patterson, seconded by Mrs. Hamilton and carried that three club teas be held at intervals during the season on a Saturday afternoon in the clubhouse. The following ladies are to act as conveners of groups, bringing in turn all lady members, Mrs. Parkes, Mrs. Patterson and Mrs Hamilton. We then adjourned to participate in the sealed hole competition and a delightful tea served by the president.

July 27th/26

A meeting of the Ladies Committee was held on Mrs. Hodges' verandah. A request from the older girls to be allowed to enter the ladies competitions was discussed. It was agreed to permit those over 13 years of age to enter. The question of lockers on the golf course arose. It was decided to write a letter to the Men's Committee advising them that an offer of a number of metal lockers, at what appeared to be a reasonable figure, had been made to Mrs. Hodges at \$1.25 each. The ladies will pay their full share of installing the same if the gentlemen deemed the offer satisfactory. It was agreed that tea towels and a pail be purchased. It was moved by Mrs. Culross that Mrs. Parkes be asked to make a list of members, and notify them as to when their turn arrives to launder and replace the small towels at the sand boxes. It was also decided to write to the Men's Committee, asking them to consider the advisability of inquiring into a daily mail for Dunany for the summer months.

1927

June 20th 1927

The Ladies Committee met at the house of the president to discuss the opening of the 1927 season. It was decided that a competition will be played each Thursday morning. It was recommended that the competition matches be over 9 holes. An odd extra match over 6 holes [the meaning of this sentence is not clear].

Teas and bridges came under discussion as the most popular forms of raising funds. In addition to any club functions of that kind, it was suggested that at casual gatherings of that kind, a fee of 25¢ be contributed to our funds. Tuesday, July 5th was the date agreed upon to hold the annual meeting in the clubhouse at Dunany, the secretary being instructed to send out cards notifying members of the same.

July 5th/27

The annual meeting of the Dunany Country Club was held at the clubhouse on July 5th, the president occupying the chair. The minutes of the last annual meeting were read and approved. The minutes of two committee meetings were also submitted. Mrs. Owen Martin presented the following resolution, a copy of which was sent to Miss McRobie's family:

Resolved that the ladies of Dunany Country Club bear on record the great vacancy in our ranks through the loss of our beloved Miss Anne McRobie. Our memory of her is one of the highest esteem and deepest affection. She was one whose life will always remain an inspiration in the hearts of her Dunany circle of friends.

It was decided to hold three teas at the clubhouse on Saturday afternoons in July and August, the first to be held on July 8th. Ladies in charge, Mrs. Hamilton, Patterson and Gall. It was moved by Mrs. Arthur Patterson and seconded by Mrs. Hughes that a hearty note of thanks be tendered Mr. Parkes for the most enjoyable time he afforded us all on the occasion of his competition day on Saturday July 1st. The meeting was adjourned to play golf. A refreshing cup of tea awaited us at the conclusion of the game.

1928

July 7, 1928

The annual meeting of the Ladies Branch of Dunany Country Club was held at the clubhouse on July 7th. The president occupied the chair. The minutes of the previous meeting and the treasurer's statement were read and approved. The election of officers followed. It was proposed by Miss McRobie that Mrs. Culross be our next president. Amid hearty applause, Mrs. Culross presided. It was moved by Mrs. Thos. [Thomas, T.D.] McRobie and seconded by Mrs. Dumbrille that Mrs. W.H. Sutherland be elected vice president. It was moved by Mrs. Patterson and seconded by Miss McRobie that Mrs. Martin be elected secretary-treasurer.

After a short discussion, it was decided to have a Handicap Committee consisting of a convener and two helpers. It was proposed by Miss McRobie and seconded by Mrs. Hughes that Mrs. W.J. Patterson be elected convener, with Mrs. Haldimand and Miss Joss forming the committee. Mrs. Parkes then proposed a hearty note of thanks to the retiring officers, which was met with approval by a loud clapping of hands. As our treasury had some funds, it was moved by Mrs. W.H. Sutherland that our president purchase new flags. It was proposed by Mrs. Haldimand and seconded by Mrs. Hamilton that weekly competitions be held on Tuesday of each week, but if the weather does not permit, the same to be held on Thursday. The subject of afternoon teas in the clubhouse was discussed and it was thought advisable to hold only two teas this year, the first on July 21st, the second in August, the date to be announced later.

It was proposed by Mrs. Patterson, seconded by Mrs. Parkes, that the members of Clear Lake take charge of tea on July 21st. It was moved by Mrs. Gall and seconded by Mrs. Hodges that Mrs. Brennian be the convener of the tea. It was moved by Mrs. Patterson and seconded by Mrs. McRobie that Mrs. Dumbrille be the convener of the second tea to be held in August. It was decided that in place of having a Towel Committee this season, arrangements would be made with Mr. Morrison to collect the towels, and Mrs. Parkes kindly offered to see that they would be laundered. Mrs. Hodges moved a vote of thanks to Mrs. Parkes. It was moved by Mrs. Maw and seconded by Mrs. Brennian that our committee approach the Men's Committee asking would they consider placing rustic benches on the third, fifth and ninth holes.

As the Ladies Branch of our club were still looking for the partly promised lockers, it was moved by Mrs. Hodges, seconded by Mrs. Hodgson, that we again approach the Men's Committee asking if they are considering installing the lockers, and if so, the Ladies Branch would be willing to donate \$10 towards the same. A vote of thanks was tendered Mr. W.H. Sutherland for his generous assistance to the Handicap Committee by Mrs. McRobie, which was seconded by Mrs. Hamilton. The meeting was then adjourned.

1929

July 6 1929

The annual meeting of the Ladies Branch of Dunany Country Club was held in the clubhouse on July 6, 1929. Our president presided. The minutes of the last meeting were read and approved. Mrs. Hodges then proposed that the officers remain for another year. After reading the treasurer's statement, it was felt we might use some of our funds towards a long felt want. So it was moved by Mrs. T. McRobie and seconded by Mrs. W.H. Sutherland that we ask the Men's Committee if they would consent to a putting green, quoting cost and report to Ladies Branch.

Mrs. Hodges moved the Ladies Branch purchase their own competition spoons this season. This was seconded by Mrs. Patterson. It was decided to hold just two teas again this year, as the plan had met with much success the previous season. Then Mrs. McRobie proposed and seconded by Mrs. Haldimand that Mrs. McLeod be the convener for Clear Lake in July, and for the tea in August. It was moved by Mrs. Hughes and seconded by Mrs. Hodgson that Miss McRobie take charge.

The convener of the Handicap Committee, Mrs. W.J. Patterson, reported the work done by her committee, which was received amid hearty applause. Mrs. Patterson suggested that weekly competitions be held and as the season advanced a few extra ones be added. Weekly competitions will be held Tuesdays, but if the weather does not permit, then on Wednesday. It was proposed by Mrs. Hodgson that we play for prizes on Thursdays. It was proposed by Mrs. Hodgson and seconded by Mrs. Maw that new flags be purchased this year. After discussion towards ways and means in betterment and improvement, Mrs. Hodgson moved we adjourn.

1930

July 5th 1930.

The annual meeting, which was called for 3 o'clock, had to be postponed until 5 on account of the competition, a mixed foursome, which was booked for that hour. Some of the ladies had a long wait as they had not noticed the change of time on the board, but were very sweet about it. They can always be relied on to be that! The president occupied the chair. The minutes of the previous meeting and the treasurer's statement were read and approved. The election of officers then followed after a vote of thanks had been tendered the retiring officers.

Mrs. W.H. Sutherland was elected our new president, proposed by Mrs. Culross and seconded by Mrs. Laidley. Mrs. Parkes was in the chair. Mrs. Dumbrille proposed Mrs. S. Patterson for vice president, seconded by Mrs. Hamilton. Mrs. Culross suggested that a new officer be installed to enlarge the committee and moved that a 2nd vice president be added. Mrs. Haldimand proposed Mrs. Hamilton for this office and it was seconded by Mrs. Patterson. It was moved by Mrs. Martin and seconded by Mrs. W.H. Sutherland that Mrs. Dumbrille be elected secretary-treasurer (amidst thunders of applause). We then proceeded to the business in hand.

Mrs. Culross proposed, and it was seconded by Mrs. Flotie Moore, that we should have new red flags and towels. Miss Ruth Laidley proposed our par should be reduced to 37 and our handicaps arranged accordingly. Mrs. Hamilton seconded this motion. Mrs. Patterson proposed that Classes A and B be formed. Mrs. Haldimand seconded this. Mrs. W.H. Sutherland agreed to ask Mr. Morrison to keep the towels laundered and placed at the boxes (for the season) at a fee of five dollars.

Mrs. Parkes moved that a tea be given in aid of the Red Cross of Lachute, and after discussing this matter, it was decided that the ladies of the Dunany Country Club take this over and, quite apart from the golf club, give a tea for that purpose on August 19th. The Golf Tea is to be given on July 19th, Mrs. Newman to be the convener, moved by Mrs. Parkes and seconded by Mrs. Markham. Mrs. Haldimand proposed that children under 12 should not be allowed on the course excepting between 2 and 4 P.M. on week days, but this was not thought to be wise and instead a notice should be placed on the board asking that an adult accompany children of that age to prevent accidents. Mrs. Laidley then moved that the meeting adjourn.

1931

July 2, 1931

The annual Meeting of the Ladies Branch of Dunany Country Club was held in the pavilion June 27th 1931. Only 12 members being present, it was regretted that Clear Lake was not represented. Mrs. W.H. Sutherland was in the chair. The officers were reelected unanimously for another year. In the absence of the secretary, Miss McRobie read the report which was accepted as correct.

Mrs. Hodges proposed the purchase of new flags, but the suggestion to dye the old ones was made, that apart from being faded, they were quite good. Mrs. McRobie, assisted by Mrs. Haldimand, agreed to do this work after being proposed by Miss McRobie and seconded by Mrs. Hodges. The plan was good but did not work out very well, for in a very short time, they had faded once more, and it was deemed imperative to renew them.

Mrs. W.H. Sutherland mentioned the matter of moving the pavilion, but after some discussion it was decided to leave this in abeyance. The majority were in favour of moving the club house but loath to leave the view behind.

Two teas were decided on for the season. It was proposed by Mrs Martin and seconded by Mrs Patterson that Boyd's Lake hold the first tea on July 18. It was proposed by Mrs. Hodges and seconded by Miss McRobie that Mrs. Patterson be the convener. It was proposed by Mrs. Hughes and seconded by Mrs. Hodgson that Clear Lake hold their tea on August 15 and that Mrs. Wilson be the convener,.

It was proposed by Mrs. Haldimand and seconded by Miss McRobie that a time be posted on the board to start competitions and partners to be drawn for. It was proposed by Mrs. Patterson and seconded by Mrs. Hutchison that the ladies buy a box for scorecards apart from the men. After discussing ways and means towards improving our club, Mrs. Hodges moved we adjourn.

1932

The annual meeting of the Ladies Branch of Dunany Country Club was held in the clubhouse at 2 P.M. on July 1st, 1932. Seventeen lady members were present. The minutes of the last meeting were read by Mrs. Dumbrille and were found correct. The election of officers then took place.

Mrs. Maw was proposed by Miss K. McRobie and seconded by Mrs. J.S. Parkes. Mrs. Hodges was elected captain of Handicaps and Matches, proposed by Mrs. William Haldimand, seconded by Miss McRobie. A vote of thanks to the retiring officers was then proposed by Mrs. Culross, seconded by Mrs. Hughes.

Much business was discussed and settled. Miss McRobie proposed that the ladies present the Men's branch with 100 dollars, to be applied towards the installation of the water system on the course. Miss F. Moore seconded this motion. (This we did by sending \$50.00 on July 29th and \$50.00 on September 12th) Mrs. Markham proposed that we have two mid-week bridges, one in July and one in August, with a charge of thirty-five cents, and two small prizes to be given at each. This it was thought, would add to the funds of the club. Mrs. Hughes seconded the motion. Mrs. Markham kindly offered to take charge of the July bridge with three helpers and Mrs. Haldimand of the August, with three helpers.

Miss McRobie moved that the clubhouse be boarded at the side to keep out the winds of the mountains so that the oil stove might have a fair chance in the world of sorrow. Mrs. Hodgson being fair minded, seconded this motion. It was proposed by Mrs. Newman, seconded by Mrs. Markham, that the Clear Lake Tea should take place in the third week in July. Mrs. D.C. Main to be convener, Mrs. William McLeod assisting. Mrs. Parkes proposed, seconded by Miss McRobie, that Mrs. Dumbrille be convener of the Boyd's Lake Tea the third week in August.

It was decided to buy new flags for the course. Also, the contract was renewed with Mrs. Morrison for washing the towels, as in the previous year, with a fee of \$5.00. Monday mornings and Thursday afternoons. Other matters were discussed, such as improving the pavilion, but these it was decided were better left in abeyance for the present. The meeting was adjourned.

1933

1933-1934

The annual meeting of the Ladies Branch of Dunany Country Club took place at 3 P.M. in the clubhouse Saturday July 1st. Fourteen members were present. The minutes of the previous meeting were read and accepted. It was proposed by Mrs. McRobie that Mrs. James Gall be appointed joint convener with Mrs. Clarke of the Clear Lake Tea, to take place the second Saturday in August. They to appoint their own committee.

It was proposed by Mrs. Culross, seconded by Mrs. Martin that the annual field day take place the Saturday before Labour Day at the clubhouse in Dunany, instead of at the Marlboro Golf as in previous years. A plate supper to be served. Mrs. Patterson to take charge of the supper and appoint her own committee. The members each to bring some article of food.

It was proposed by Mrs. Dumbrille, seconded by Mrs. Hamilton, that each member give some kind of entertainment with an entrance charge or in some way make extra money for the club this year – This was not to be compulsory, but only members who found it convenient were to undertake the venture. Mrs. Patterson announced that she and Mrs. Hamilton would start the ball rolling with a joint bridge the following evening with a charge of 35¢, each hostess to provide two prizes.

It was decided to eliminate the Thursday competitions and have only one competition weekly, Tuesday mornings at 9:30, leaving the balance of the week free for private competitions. Also it was decided to buy new flags for the club and Mrs. Haldimand proposed we have benches built in the shelters, seconded by Mrs. Hodgson. The meeting was then adjourned.

Following the meeting, at 4 P.M, tea was served by the ladies of Boyd's and Black Lakes, with a fee of 25¢ charged, constituting the Boyd's and Black Lake Annual Tea.

A special meeting was held at the pavilion on August 19th to discuss arrangements for the Field Day Supper. Eleven Ladies were present. Mrs. Hamilton was made convener and it was decided to ask Mr. McCracken, of Murrays Sandwich Shops, to cater for the supper. Mr. McCracken has estimated the cost would be 27¢ per plate, which the whole club thought was an extremely low figure. Trestle tables to be set up to seat thirty at each table. Mrs. Dumbrille proposed, seconded by Mrs. W.H. Sutherland, that all children be included for the supper, charging 50¢ for children under 14 and 75¢ for all adults.

Different members offered knives, forks, spoons, table covers cups and saucers. Mrs. Martin proposed that Mrs. A.W. Smith and Mrs. Henry Hodges be appointed to decorate the tables and Mrs. Haldimand, Brennan and Maw offered to set the tables. All members present promised to help generally setting out food, etc. Mrs. Martin and Mrs. Dumbrille offered to make and serve the coffee.

[1933 continued]

It was proposed by Mrs. Haldimand seconded by Mrs. Patterson that the evening end with a bonfire and sing song. It was announced that Mr. John Freeman had donated 10 lbs. of butter toward the event and Mrs. Culross and Maw the paper plates, cups and serviettes and doilies "let not your left hand know" [a biblical reference (Matthew 6:3-4), that giving will be rewarded by God even if it is not publicly recognized].

It was decided to have Wilma Brown wash cups and saucers and Mrs. W.H. Sutherland (the president) was to ask if the workmen on the course might be freed that morning to lend a hand towards setting up the tables, etc. The meeting was then adjourned. After, it was decided to present the Men's Branch with one hundred dollars at the close of the Field Day and season.

1934

1934-1935

The annual meeting of the Ladies Branch of the Dunany Country Club took place at the clubhouse on Saturday, June 29th. Eleven members were present. The minutes of the previous meeting were read and accepted. The treasurer reported thirty-two dollars and sixty-eights cents (\$32.68) in the bank. The election of officers then took place. president, Mrs. Dumbrille, proposed by Mrs. Hodges, seconded by Miss Moore. first vice president, Mrs. Maw, proposed by Miss Moore, seconded by Mrs. Martin. second vice president, Mrs. Smith, proposed by Mrs. McRobie, seconded by Mrs. Haldimand. secretary-treasurer, Mrs. Hodgson, proposed by Miss Moore, seconded by Mrs. Haldimand. Mrs. Brennian was proposed for captain of the Match Committee, assisted by Vida Fish and Helen Martin. Mrs. Brennian was not able to accept the office and Miss Fish and Mrs. Martin took charge.

A note of thanks was then proposed to the returning officers by Mrs. Haldimand and seconded by Mrs. Clarke. It was then proposed that Mrs. Clarke and Mrs. Parkes take charge of Clear Lake Tea on July 14th, Mrs. Maw to be convener of the Boyd Lake Tea on August 11th.

The ladies voted that the Field Day be held at Dunany as last year. It was suggested that social bridges be held to raise money, the refreshments to be very simple. Tuesday morning was selected for the regular spoon competition. It was moved by Mrs. Patterson that prizes be given for a Mixed Two-Ball Foursome. It was also proposed that the ladies buy new flags and that we should have Mrs. Morrison to wash the towels as usual. The meeting was then adjourned.

A special meeting was held to arrange for the Dunany Field Day in August but the plans made were cancelled by a second meeting and the catering was to be done by Murrays Lunch. Approved found correct.

The annual meeting of the Dunany Country Club took place at the clubhouse on June 29th 1935, seventeen members being present. Mrs. Dumbrielle was in the chair. Minutes of last meeting were read and approved. Mrs. Culross proposed the the teas be held as usual, seconded by Miss McRobie. The Boyd Lake Tea to be held July 13th, convener Mrs. Patterson, proposed by Mrs. Maw, seconded by Mrs. Hodges. Committee: Mrs. McRobie, Mrs. Haldimand, Mrs. Hodgson, Mrs. Maw The Clear Lake Tea to be held August 3rd, convener Mrs. Gall assisted by Mrs. Wilson, proposed by Mrs. Parkes, seconded by Mrs. Hodges.
